BOC Program

Building Operator Certification (BOC) is a professional certification program for staff that operates and maintains commercial and public buildings.

Operators earn certification by attending training sessions and completing project assignments in their facilities. The certification provides a credential for their professional development while also offering employers a way to identify skilled staff.

The Ohio Department of Development has obtained a license for implementation of the BOC program in Ohio. OPFMA is a 501(c)(3) nonprofit educational association that organizes the BOC series across Ohio. OPFMA contracts and coordinates the BOC Instructors, the BOC students and class logistics, as well as the administrative and financial affairs related with the BOC program across the state.

Participants attend eight days BOC classes, one day per month, and upon a successful completion of each class' test and in-facility projects, they receive the Building Operator Certificate from Midwest Energy Efficiency Alliance (MEEA) – Chicago, Illinois.

The BOC Program gets lots of attention among those who provides us with safety and wonderful living conditions in the public facilities. The program has been successful at improving the comfort in public facilities as well as saving energy and money.

The Northwest Energy Efficiency Alliance found that over 65% of BOC certified operators are applying concepts learned in training and 26% undertake specific measures such as large energy conservation projects and IAQ improvements. They also estimate that there is an average annual energy savings of 28,600 kWh per participant.



2006 BOC Series

We are pleased to let you know that last month another BOC Series was started in Columbus!

The BOC May 12th Series (05-12-06 Series) is hosted by State Library of Ohio. The "May BOC Class" will graduate in November 2006.

At this time we are organizing another BOC Series. It starts on July 14th and it will be hosted by Apollo Career Center in Lima. This BOC class will graduate in Jan 2007.

July is a busy month – the BOC "Apollo Series" begins its study while the "Trane Series", the largest BOC class, has its finals. We wish them success!

The planning and work behind the scenes is a non-stop process. The next area we are focusing at and starting to organize a BOC class is the Cleveland area, tentatively scheduled for late August. Also, we are planning to close the 2006 year with yet another BOC class aiming for early December. The location of this class will be determined by market demand.

Universal Waste Management: Is Your Facility Properly Handling Universal Waste?

Are boxes of obsolete computers, spent batteries, or waste-lamps piling up in a back room or basement of your facility? Has a renovation or demolition project left you with piles of old light ballasts and mercury-containing thermostats? If so, your operation could be considered by the Ohio EPA to be a small quantity generator of hazardous wastes and subject to hazardous waste rules. To encourage recycling, Ohio EPA regulates certain wastes, called Universal Wastes (UW), differently than hazardous wastes even though these wastes may display certain toxicity characteristics. This allows facilities managers to avoid the high costs and hassles of disposal.

The four major types of UW are:

- (1) Lamps including incandescent, fluorescent, high intensity discharge, neon, mercury vapor, high-pressure sodium and metal halide lamps;
- (2) Pesticides that are either suspended and recalled under Section 6 of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), suspended or cancelled as part of a voluntary recall by the registrant, or collected in waste pesticide programs;
- (3) Mercury-containing thermostats; and
- (4) Discarded batteries.

According to the Universal Waste Rules (Ohio Administrative Code 3745-273) there are three types of UW management: handlers, transporters, and destination facilities. As a UW generator, you are considered a handler. You, or a trusted waste services provider like Emerald Environmental Services, can manage and dispose of these hidden hazards simply, safely, and inexpensively under the Universal Waste Rules.

You are required to follow some simple guidelines in the disposal of your universal waste. Lamp bulbs or tubes cannot be crushed. Handlers can remove mercury-containing ampoules from thermostats as long as the process prevents breakage and is done over a containment vessel in a well-ventilated and monitored area meeting OSHA specifications. Universal wastes must be, in general, handled without breakage and packaged in secure and compatible containers that are clearly labeled. Handlers can store UW on site for up to one year without written documentation
